SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF
MUK CHUN STREET, SHING KAI ROAD ROUNDABOUT, AND
SECTIONS OF CONCORDE ROAD AND SHING KAI ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 11 December 2015 (the 'Order'), authorized:—

- (I) the temporary partial closure of Muk Chun Street, as delineated and shown in blue on the Plan numbered SCL/G13/0025/4;
- (II) the temporary partial closure of Shing Kai Road Roundabout, as delineated and shown in yellow on the Plan numbered SCL/G13/0025/4; and
- (III) the temporary partial closure of the section of Concorde Road between its junction with Shing Kai Road Roundabout and a point about 20 metres west of the junction, and the section of Shing Kai Road between its junction with Shing Kai Road Roundabout and a point about 20 metres east of the junction, as delineated and shown in beige and orange respectively on the Plan numbered SCL/G13/0025/4,

during the period from 1 January to 30 September 2016 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G13/0025/4 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the roads affected by the Order on 18 December 2015.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
