SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF A PEDESTRIAN SUBWAY
CONNECTING OLYMPIC GARDEN AND
THE JUNCTION OF ARGYLE STREET AND PRINCE EDWARD ROAD WEST,
A PEDESTRIAN SUBWAY CONNECTING OLYMPIC GARDEN AND
THE JUNCTION OF ARGYLE STREET AND MA TAU CHUNG ROAD, AND
A PEDESTRIAN SUBWAY CONNECTING OLYMPIC GARDEN AND
PRINCE EDWARD ROAD WEST; AND TEMPORARY ALTERATION OF
A SECTION OF PRINCE EDWARD ROAD WEST**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 14 December 2015 (the 'Order'), authorized:—

- (I) (a) the temporary closure of the pedestrian subway connecting Olympic Garden and the junction of Argyle Street and Prince Edward Road West, as delineated and shown in blue on the Plans numbered SCL/G19/0042/2 and SCL/G22/0042/2; and
- (b) the temporary partial closure of the pedestrian subway connecting Olympic Garden and the junction of Argyle Street and Ma Tau Chung Road, as delineated and shown in orange on the Plans numbered SCL/G19/0042/2 and SCL/G22/0042/2,

during the period from 1 January to 30 September 2016; and

- (II) (a) the temporary partial closure of the pedestrian subway connecting Olympic Garden and Prince Edward Road West, as delineated and shown in yellow on the Plans numbered SCL/G19/0042/2 and SCL/G22/0042/2; and
- (b) the temporary alteration of the section of Prince Edward Road West between its junctions with Hau Wong Road and South Wall Road, as delineated and shown in pink on the Plans numbered SCL/G19/0042/2 and SCL/G22/0042/2,

during the period from 1 January to 30 December 2016,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the pedestrian subways and the section of the road to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G19/0042/2 and SCL/G22/0042/2 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near the pedestrian subways and the road affected by the Order on 18 December 2015.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure/alteration of the relevant part or parts of the pedestrian subways and the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the pedestrian subways and the road affected by the Order.

Notice is hereby given that further closure/alteration of the same part or parts of the pedestrian subways and the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.
