AUTHORIZATION FOR TEMPORARY CLOSURE OF A SECTION OF PRINCE EDWARD ROAD WEST; PART OF SUNG WONG TOI PLAYGROUND; OLYMPIC GARDEN; AND PEDESTRIAN SUBWAYS CONNECTING OLYMPIC GARDEN AND PRINCE EDWARD ROAD WEST, CONNECTING OLYMPIC GARDEN AND THE JUNCTION OF ARGYLE STREET AND MA TAU CHUNG ROAD, AND CONNECTING OLYMPIC GARDEN AND THE JUNCTION OF ARGYLE STREET AND PRINCE EDWARD ROAD WEST

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:-

- (I) the temporary partial closure of the section of Prince Edward Road West between its junctions with Hau Wong Road and Lung Kong Road, as delineated and shown in pink on the Plans numbered SCL/G19/0042/4 and SCL/G22/0042/4 during the period from 31 December 2017 to 30 April 2018;
- (II) (a) the temporary closure of part of Sung Wong Toi Playground, as delineated and shown in red on the Plans numbered SCL/G19/0042/4 and SCL/G22/0042/4;
 - (b) the temporary partial closure of Olympic Garden, as delineated and shown in green on the Plans numbered SCL/G19/0042/4 and SCL/G22/0042/4; and
 - (c) the temporary partial closure of the pedestrian subway connecting Olympic Garden and Prince Edward Road West, as delineated and shown in yellow on the Plans numbered SCL/G19/0042/4 and SCL/G22/0042/4,

during the period from 31 December 2017 to 30 June 2018; and

- (III) (a) the temporary closure of the pedestrian subway connecting Olympic Garden and the junction of Argyle Street and Ma Tau Chung Road, as delineated and shown in brown on the Plans numbered SCL/G19/0042/4 and SCL/G22/0042/4; and
 - (b) the temporary partial closure of the pedestrian subway connecting Olympic Garden and the junction of Argyle Street and Prince Edward Road West, as delineated and shown in blue on the Plans numbered SCL/G19/0042/4 and SCL/G22/0042/4,

during the period from 1 January to 30 April 2018.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over (i) the section of the road as described in (I) above during the period from 31 December 2017 to 30 April 2018; (ii) the part of Sung Wong Toi Playground, Olympic Garden and the pedestrian subway as described in (II) above during the period from 31 December 2017 to 30 June 2018; and (iii) the pedestrian subways as described in (III) above during the period from 31 December 2017 to 30 June 2018; and (iii) the pedestrian subways as described in (III) above during the period from 1 January to 30 April 2018, shall be extinguished, modified or restricted, as the case may be.
