RAILWAYS ORDINANCE (Chapter 519)

SHATIN TO CENTRAL LINK

NOTICE is hereby given that under section 11(4) of the Railways Ordinance (Chapter 519), the Chief Executive in Council has authorized the scheme as described in G.N. 7301 published on 26 November and 3 December 2010, as amended under G.N. 4423 published on 15 and 22 July 2011, and as amended and corrected under G.N. 7326 published on 11 and 18 November 2011, and has imposed the modification as described in the Schedule of Modification and shown on the Creation of Rights of Temporary Occupation of Land Plan No. SCL-T01 (Revision 1) (the 'Modification Plan') annexed thereto. The Schedule of Modification and the Modification Plan have been deposited in the Land Registry.

The general nature and extent of the modification is as follows:—

Item M1 The proposed creation of rights of temporary occupation of land at the Green Hatched Black Area attached to Sha Tin Town Lot No. 503 is deleted.

Item M1 is shown on the Creation of Rights of Temporary Occupation of Land Plan No. SCL-T01 (Revision 1).
