# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF PART OF KING GEORGE V MEMORIAL PARK, HONG KONG, CENTRE STREET SITTING-OUT AREA, AND SECTIONS OF HIGH STREET AND SECOND STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 10 July 2015 (the 'Order'), authorized:—

- (I) the temporary closure of part of King George V Memorial Park, Hong Kong, as delineated and shown in yellow on the Plan numbered WIL/G05/0008/6 during the period from 6 August to 31 December 2015;
- (II) the temporary partial closure of the section of High Street between its junction with Eastern Street and a point about 60 metres east of the junction, as delineated and shown in green on the Plan numbered WIL/G05/0008/6 during the period from 1 October to 31 December 2015;
- (III) (a) the temporary closure of Centre Street Sitting-out Area, as delineated and shown in red on the Plan numbered WIL/G05/0008/6; and
  - (b) the temporary partial closure of the section of Second Street between its junction with Centre Street and a point about 110 metres west of the junction, as delineated and shown in orange on the Plan numbered WIL/G05/0008/6,

during the period from 6 August 2015 to 5 August 2016,

for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out, the areas of King George V Memorial Park, Hong Kong and Centre Street Sitting-out Area, and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of King George V Memorial Park, Hong Kong, Centre Street Sitting-out Area and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of King George V Memorial Park, Hong Kong, Centre Street Sitting-out Area and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of King George V Memorial Park, Hong Kong, Centre Street Sitting-out Area and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

### **SCHEDULE**

King George V Memorial Park, Hong Kong, Centre Street Sitting-out Area and the roads to be affected

(a) Part of King George V Memorial Park, Hong Kong, as delineated and shown in yellow on the Plan numbered WIL/G05/0008/6. Part of King George V Memorial Park, Hong Kong will be temporarily closed to facilitate the reinstatement works King George V Memorial Park, Hong Kong, Centre Street Sitting-out Area and the roads to be affected Description of the works and the manner in which King George V Memorial Park, Hong Kong, Centre Street Sitting-out Area and the roads will be affected

(b) The section of High Street between its junction with Eastern Street and a point about 60 metres east of the junction, as delineated and shown in green on the Plan numbered WIL/G05/0008/6. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the reinstatement works

- (c) Centre Street Sitting-out Area, as delineated and shown in red on the Plan numbered WIL/G05/0008/6.
- Centre Street Sitting-out Area will be temporarily closed to facilitate the reinstatement works.
- (d) The section of Second Street between its junction with Centre Street and a point about 110 metres west of the junction, as delineated and shown in orange on the Plan numbered WIL/G05/0008/6

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the reinstatement works
