Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 21 November 2011 (the 'Order'), authorized the temporary closure of the open space in Forbes Street Temporary Playground and parts of the open space in Kennedy Town Playground, and the temporary partial closure of sections of Smithfield between a point about 15 metres north of Rock Hill Street and Pokfield Path and sections of Forbes Street between Smithfield and Cadogan Street, and the temporary closure of a section of the road adjacent to Forbes Street Temporary Playground and Kennedy Town Playground during the period from 11 December 2011 to 10 December 2012 for the purposes of or incidental to the railway scheme of the MTR West Island Line. A description of the works to be carried out and the areas of the open space and the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered WIL/G02/0003/1 (the 'Plan'), delineating and showing the parts of the open space and the sections of the roads affected in yellow, pink, blue and green respectively, may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the open space and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open space and the roads affected by the Order. Such a written claim should reach the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong on or before 31 December 2011; or the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong on or after 1 January 2012.

Notice is hereby given that further closure of the same part or parts of the open space and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

The open space and the roads to be affected

- (a) The open space in Forbes Street Temporary Playground and parts of the open space in Kennedy Town Playground, as delineated and shown in yellow on the Plan numbered WIL/G02/0003/1.
- (b) Sections of Smithfield between a point about 15 metres north of Rock Hill Street and Pokfield Path, as delineated and shown in pink on the Plan numbered WIL/G02/0003/1.
- (c) Sections of Forbes Street between Smithfield and Cadogan Street, as delineated and shown in blue on the Plan numbered WIL/G02/0003/1.
- (d) A section of the road adjacent to Forbes Street Temporary Playground and Kennedy Town Playground as delineated and shown in green on the Plan numbered WIL/G02/0003/1.
