**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF A SECTION OF JORDAN ROAD AND
PARTS OF A FOOTBRIDGE AT JORDAN ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 10 March 2014 (the ‘Order’), authorized:-

- (I) the temporary closure of the section of Jordan Road between a point about 10 metres southeast of its junction with Lin Cheung Road and a point about 150 metres southeast of the junction, as delineated and shown in green on the Plan numbered XRL/G44/0014/2 during the period from 1 April to 15 December 2014; and
- (II) the temporary closure of three parts of the footbridge on the northern side of Jordan Road between MTR Austin Station and MTR Kowloon Station, as delineated and shown in red, green and blue on the Plan numbered XRL/G44/0016/2 during the period from 1 April 2014 to 30 September 2015,

for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the sections of the footbridge and the road to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered XRL/G44/0014/2 and XRL/G44/0016/2 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the road and footbridge affected by the Order on 14 March 2014.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the footbridge and the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge and the road affected by the Order.

Notice is hereby given that further closure of the same part or parts of the road and footbridge or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) The section of Jordan Road between a point about 10 metres southeast of its junction with Lin Cheung Road and a point about 150 metres southeast of the junction, as delineated and shown in green on the Plan numbered XRL/G44/0014/2.	The carriageways, footpaths and the central divider will be temporarily closed to facilitate the construction of the approach tunnel of the terminus and a footbridge under the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.

(b) Three parts of the footbridge on the northern side of Jordan Road between MTR Austin Station and MTR Kowloon Station, as delineated and shown in red, green and blue on the Plan numbered XRL/G44/0016/2.

The parts of the footbridge decks will be temporarily closed to facilitate the construction of the approach tunnel of the terminus and a footbridge under the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.

Statement on Personal Data
