NOTICE OF ORDER AUTHORIZING TEMPORARY ALTERATION OF
SECTIONS OF HOI WANG ROAD AND HOI TING ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 12 March 2012 (the 'Order'), authorized the temporary alteration of sections of Hoi Wang Road between a point about 80 metres south of its junction with Hoi Ting Road and a point about 470 metres north of the junction; and the temporary alteration of sections of Hoi Ting Road between a point about 60 metres east of its junction with Hoi Wang Road and a point about 80 metres west of the junction during the period from 1 April 2012 to 31 March 2013 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered XRL/G42/0009/1 and XRL/G43/0009/2 delineating and showing in red and yellow the sections of the roads affected may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the roads affected by the Order on 16 March 2012.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the alteration of the relevant part or parts of the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further alteration of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for alteration will be published if and when such an order is made.

(a) Sections of Hoi Wang Road between a point about 80 metres south of its junction with Hoi Ting Road and a point about 470 metres north of the junction, as delineated and shown in red on the Plans numbered XRL/G42/0009/1 and XRL/G43/0009/2.	Parts of the carriageways and footpaths will be temporarily altered to facilitate the construction of the railway tunnel of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.
(b) Sections of Hoi Ting Road between a point about 60 metres east of its junction with Hoi Wang Road and a point about 80 metres west of the junction, as delineated and shown in yellow on the Plan numbered XRL/G43/0009/2.	Parts of the carriageways and footpaths will be temporarily altered to facilitate the construction of the railway tunnel of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.
