NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF THREE SECTIONS OF  
A FOOTBRIDGE AT JORDAN ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 28 March 2012 (the 'Order'), authorized:—

- (I) the temporary closure of a footbridge section on the northern side of Jordan Road between MTR Austin Station and MTR Kowloon Station, as delineated and shown in red on the Plan numbered XRL/G44/0016/1;
- (II) the temporary closure of parts of a footbridge section across Jordan Road connecting to MTR Austin Station, as delineated and shown in green on the Plan numbered XRL/G44/0016/1; and
- (III) the temporary closure of parts of a footbridge section across Jordan Road connecting to MTR Kowloon Station, as delineated and shown in blue on the Plan numbered XRL/G44/0016/1,

during the period from 20 April 2012 to 31 March 2014 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out and the sections of the footbridge to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the footbridge affected by the Order on 5 April 2012.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the footbridge or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge affected by the Order.

Notice is hereby given that further temporary closure of the same part or parts of the footbridge or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

<i>The footbridge to be affected</i>	<i>Description of the works and the manner in which the footbridge will be affected</i>
(a) The footbridge section on the northern side of Jordan Road between MTR Austin Station and MTR Kowloon Station, as delineated and shown in red on the Plan numbered XRL/G44/0016/1.	The footbridge deck will be temporarily closed and demolished to facilitate the construction of the approach tunnel of the terminus and the construction of the footbridge of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.
(b) The footbridge section across Jordan Road connecting to MTR Austin Station, as delineated and shown in green on the Plan numbered XRL/G44/0016/1.	Parts of the footbridge deck will be temporarily closed to facilitate the construction of the approach tunnel of the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.
(c) The footbridge section across Jordan Road connecting to MTR Kowloon Station, as delineated and shown in blue on the Plan numbered XRL/G44/0016/1.	Parts of the footbridge deck will be temporarily closed and demolished to facilitate the construction of the approach tunnel of the terminus and the construction the footbridge of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.
