OF THE JUNCTION OF JORDAN ROAD AND LIN CHEUNG ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 6 May 2011 (the 'Order'), authorized the permanent closure of a footbridge ramp and a footbridge staircase at the northwest and the northeast respectively of the junction of Jordan Road and Lin Cheung Road with effect from 27 May 2011 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the footbridge ramp and the footbridge staircase to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered XRL/G44/0008/1 (the 'Plan') delineating and showing the affected footbridge ramp and footbridge staircase in yellow and red respectively may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the footbridge ramp and the footbridge staircase or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge ramp and the footbridge staircase affected by the Order.

SCHEDULE

The footbridge ramp and the footbridge staircase to be affected

- (a) The footbridge ramp at the northwest of the junction of Jordan Road and Lin Cheung Road, as delineated and shown in yellow on the Plan numbered XRL/G44/0008/1.
- (b) The footbridge staircase at the northeast of the junction of Jordan Road and Lin Cheung Road, as delineated and shown in red on the Plan numbered XRL/G44/0008/1.

Description of the works and the manner in which the footbridge ramp and the footbridge staircase will be affected

The footbridge ramp will be permanently closed to facilitate the construction of a temporary footbridge and the approach tunnel to the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.

The footbridge staircase will be permanently closed to facilitate the construction of the approach tunnel to the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.

Statement on Personal Data
