Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 27 May 2015 (the 'Order'), authorized the temporary closure of the section of Jordan Road between a point about 10 metres southeast of its junction with Lin Cheung Road and a point about 150 metres southeast of the junction, as delineated and shown in green on the Plan numbered XRL/G44/0014/3 during the period from 1 July to 31 July 2015 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the section of the road to be affected and the manner in which it will be affected is given in the Schedule below.

Notice is hereby given that further closure of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

The section of Jordan Road between a point about 10 metres southeast of its junction with Lin Cheung Road and a point about 150 metres southeast of the junction, as delineated and shown in green on the Plan numbered XRL/G44/0014/3.

The carriageways, footpaths and the central divider will be temporarily closed to facilitate the construction of the approach tunnel of the terminus and the footbridge of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link, and the road reinstatement works.
