**NOTICE OF ORDER AUTHORIZING**  
**TEMPORARY CLOSURE OF A FOOTBRIDGE**  
**AT THE JUNCTION OF SHAM MONG ROAD AND HOI FAI ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Acting Deputy Secretary for Transport and Housing (Transport) has, by order made on 8 August 2012 (the ‘Order’), authorized the temporary closure of a footbridge at the junction of Sham Mong Road and Hoi Fai Road during the period from 3 September 2012 to 31 March 2013 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the footbridge to be affected and the manner in which it will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered XRL/G41/0004/1 (the ‘Plan’) delineating and showing the footbridge affected in red may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the footbridge affected by the Order on 17 August 2012.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the footbridge or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge affected by the Order.

*Description of the works and the manner in which the footbridge will be affected*

The footbridge at the junction of Sham Mong Road and Hoi Fai Road, as delineated and shown in red on the Plan.

---

The footbridge will be temporarily closed to facilitate the construction of the railway tunnel of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link and subsequent re-construction of the footbridge deck and piles, a footbridge staircase and two lifts near Nam Cheong Park which had been demolished due to the construction works.
