**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF A SLIP ROAD FROM LIN CHEUNG ROAD TO
CROSS-BORDER COACH TERMINUS AT MTR KOWLOON STATION, AND
SECTIONS OF LIN CHEUNG ROAD AND AUSTIN ROAD WEST**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 28 August 2019 (the 'Order'), authorized:-

- (I) the temporary closure of the slip road from Lin Cheung Road to Cross-Border Coach Terminus at MTR Kowloon Station, as delineated and shown in yellow on the Plans numbered XRL/G45/0027/2 and XRL/G46/0027/2; and
- (II) the temporary partial closure of the section of Lin Cheung Road between Jordan Road and Austin Road West, and the section of Austin Road West between its junction with Lin Cheung Road and a point about 70 metres west of the junction, as delineated and shown in green and red respectively on the Plans numbered XRL/G45/0027/2 and XRL/G46/0027/2,

during the period from 1 October 2019 to 31 March 2020 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered XRL/G45/0027/2 and XRL/G46/0027/2 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 13 September 2019.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means:–

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
