NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF TWO SECTIONS OF FLYOVERS AND SLIP ROADS AT  
THE WEST OF THE JUNCTION OF HOI WANG ROAD AND NGO CHEUNG ROAD  
TO WESTERN HARBOUR CROSSING AND LIN CHEUNG ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 7 September 2011 (the 'Order'), authorized the temporary closure of two sections of flyovers and slip roads, between about 30 metres west of the junction of Hoi Wang Road and Ngo Cheung Road and about 230 metres west of the junction, to Western Harbour Crossing and Lin Cheung Road during the period from 3 October 2011 to 31 August 2015 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out and the parts of the flyovers and slip roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered XRL/G44/0011/1 (the 'Plan') delineating and showing the affected sections of flyovers and slip roads in red and green respectively may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the roads affected by the Order on 16 September 2011.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the flyovers and slip roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the flyovers and slip roads affected by the Order. Such a written claim should reach the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong on or before 31 December 2011; or the Secretary for Transport and Housing on 22nd Floor, East Wing,

Central Government Offices, 2 Tim Mei Avenue, Admiralty, Hong Kong on or after 1 January 2012.

#### SCHEDULE

*The flyovers and slip roads to be affected*

Two sections of flyovers and slip roads, between about 30 metres west of the junction of Hoi Wang Road and Ngo Cheung Road and about 230 metres west of the junction, to Western Harbour Crossing and Lin Cheung Road, as delineated and shown in red and green respectively on the Plan numbered XRL/G44/0011/1.

*Description of the works and the manner in which the flyovers and slip roads will be affected*

The parts of the flyovers and slip roads will be temporary closed to facilitate the construction of the approach tunnel to the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.

**Statement on Personal Data**

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims as required under section 34 of the Railways Ordinance (Chapter 519) will be used for the processing of the claims and other related purposes.
