# NOTICE OF ORDER AUTHORIZING PERMANENT CLOSURE OF TWO SECTIONS OF FLYOVERS AND SLIP ROADS AT THE WEST OF THE JUNCTION OF HOI WANG ROAD AND NGO CHEUNG ROAD TO WESTERN HARBOUR CROSSING AND LIN CHEUNG ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 7 August 2015 (the 'Order'), authorized the permanent closure of two sections of flyovers and slip roads, between a point about 30 metres west of the junction of Hoi Wang Road and Ngo Cheung Road and a point about 230 metres west of the junction, to Western Harbour Crossing and Lin Cheung Road, as delineated and shown in red and green respectively on the Plan numbered XRL/G44/0011/2 with effect from 1 Septmber 2015 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the sections of the flyovers and the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the flyovers and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the flyovers and the roads affected by the Order

The flyovers and the roads to be affected

Description of the works and the manner in which the flyovers and the roads will be affected

Two sections of flyovers and slip roads, between a point about 30 metres west of the junction of Hoi Wang Road and Ngo Cheung Road and a point about 230 metres west of the junction, to Western Harbour Crossing and Lin Cheung Road, as delineated and shown in red and green respectively on the Plan numbered XRL/G44/0011/2

The carriageways will be permanently closed and demolished to facilitate the construction of the approach tunnel to the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.
