

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

**HONG KONG SECTION OF
GUANGZHOU-SHENZHEN-HONG KONG EXPRESS RAIL LINK**

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF
SECTIONS OF TAI TSUN STREET, KOK CHEUNG STREET,
CHUNG WUI STREET AND WONG TAI STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 1 February 2013 (the 'Order'), authorized:—

- (I) the temporary partial closure of the section of Tai Tsun Street between its junction with Kok Cheung Street and a point about 50 metres east of the junction, as delineated and shown in red on the Plan numbered XRL/G41/0015/2;
- (II) the temporary partial closure of sections of Kok Cheung Street between Tai Tsun Street and Chung Wui Street; and between the junction of Kok Cheung Street and Chung Wui Street and a point about 8 metres north of the junction, as delineated and shown in yellow on the Plan numbered XRL/G41/0015/2;
- (III) the temporary partial closure of the section of Chung Wui Street between its junction with Wong Tai Street and a point about 13 metres east of its junction with Kok Cheung Street, as delineated and shown in green on the Plan numbered XRL/G41/0015/2; and
- (IV) the temporary partial closure of the section of Wong Tai Street between its junction with Chung Wui Street and a point about 17 metres south of the junction, as delineated and shown in purple on the Plan numbered XRL/G41/0015/2,

during the period from 27 February 2013 to 26 February 2014 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the roads affected by the Order on 8 February 2013.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
