

**RAILWAYS ORDINANCE (Chapter 519)

**HONG KONG SECTION OF  
GUANGZHOU-SHENZHEN-HONG KONG EXPRESS RAIL LINK**

**NOTICE OF ORDER AUTHORIZING  
PERMANENT ALTERATION OF SECTIONS OF LIN CHEUNG ROAD,  
WUI CHEUNG ROAD, WUI MAN ROAD AND AUSTIN ROAD WEST**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 17 September 2018 (the ‘Order’), authorized:–

- (I) the permanent alteration of the section of Lin Cheung Road between a point about 80 metres north of its junction with Jordan Road and a point about 210 metres north of the junction, and the section of Lin Cheung Road between a point about 190 metres north of its junction with Jordan Road and a point about 220 metres north of the junction, as delineated and shown in green on the Plan numbered XRL/G44/0028/1;
- (II) the permanent alteration of the section of Lin Cheung Road between Jordan Road and Austin Road West, as delineated and shown in pink on the Plans numbered XRL/G44/0028/1, XRL/G45/0028/1 and XRL/G46/0028/1;
- (III) the permanent alteration of the section of Wui Cheung Road between Canton Road and a point about 25 metres west of its junction with Wui Man Road, and the section of Wui Man Road between Wui Cheung Road and Austin Road West, as delineated and shown in yellow and blue respectively on the Plan numbered XRL/G45/0028/1; and
- (IV) the permanent alteration of the section of Austin Road West between a point about 60 metres east of its junction with Lin Cheung Road and a point about 165 metres west of the junction, and the section of Austin Road West between a point about 80 metres east of its junction with Lin Cheung Road and a point about 295 metres east of the junction, as delineated and shown in red on the Plans numbered XRL/G45/0028/1 and XRL/G46/0028/1,

with effect from 1 October 2018 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered XRL/G44/0028/1, XRL/G45/0028/1 and XRL/G46/0028/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 21 September 2018.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the alteration of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means: –
