NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF A FOOTBRIDGE  
AT THE JUNCTION OF SHAM MONG ROAD AND SHAM SHING ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 26 November 2010 (the 'Order'), authorized the temporary closure of a footbridge at the junction of Sham Mong Road and Sham Shing Road during the period from 17 December 2010 to 5 October 2012 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the footbridge to be affected and the manner in which it will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered XRL/G38/0006/1 (the 'Plan') delineating and showing the footbridge affected in red, may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the footbridge affected by the Order on 3 December 2010.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the footbridge or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridge affected by the Order.

Notice is hereby given that further closure of the same part or parts of the footbridge or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

## SCHEDULE

### *The footbridge to be affected*

The footbridge at the junction of Sham Mong Road and Sham Shing Road, as delineated and shown in red on the Plan numbered XRL/G38/0006/1.

### *Description of the works and the manner in which the footbridge will be affected*

To facilitate the construction of the railway tunnel of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link, the footbridge will be temporarily closed. During construction, the footbridge decks and piles, a footbridge staircase and two lifts (near Hong Kong Institute of Vocational Education Haking Wong Waterfront Annex) will be demolished and subsequently re-constructed.

#### **Statement on Personal Data**

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims as required under section 34 of the Railways Ordinance (Chapter 519) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 34 of the Railways Ordinance is obligatory. If such information, including the personal data, as required under section 34 of the Railways Ordinance is not provided as requested, the claims may be rejected.
