NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF WUI MAN ROAD, AND A SECTION OF AUSTIN ROAD WEST

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 4 December 2017 (the 'Order'), authorized:—

- (I) the temporary closure of Wui Man Road, as delineated and shown in red on the Plan numbered XRL/G45/0026/1; and
- (II) the temporary partial closure of the section of Austin Road West between a point about 20 metres east of its junction with Lin Cheung Road and a point about 320 metres west of the junction, as delineated and shown in green on the Plans numbered XRL/G45/0026/1 and XRL/G46/0017/4,

during the period from 1 January to 30 June 2018 for the purposes of or incidental to the railway scheme of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

The roads to be affected

Description of the works and the manner in which the roads will be affected

Wui Man Road, as delineated and shown. The carriageway and footnath widths will

(a) Wui Man Road, as delineated and shown in red on the Plan numbered XRL/G45/0026/1.

(b) The section of Austin Road West between a point about 20 metres east of its junction with Lin Cheung Road and a point about 320 metres west of the junction, as delineated and shown in green on the Plans numbered XRL/G45/0026/1 and XRL/G46/0017/4. The carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated road networks for the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the underpass near the terminus of the Hong Kong Section of Guangzhou-Shenzhen-Hong Kong Express Rail Link, and reinstatement works.
