**ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)**  
**(Notice under section 11(9)(d))**

**PWP ITEM NO. 6806TH DUALLING OF HIRAM'S HIGHWAY  
FROM MARINA COVE TO SAI KUNG TOWN**

Notice is hereby given that under section 11(2)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Chief Executive in Council has authorized the works and the use as described in G.N. 43 published on 3 January 2020 and 10 January 2020 as amended by the works and the use as described in G.N. 6680 published on 20 November 2020 and 27 November 2020 and with modifications described hereunder. The modifications involve modification to limit of works area as shown on Modification Plan Nos. 91272/GAZ/2100A to 91272/GAZ/2105A (the 'Modification Plans') and revision to resumption/clearance limit, as shown on Resumption Plan No. SKM8681f (the 'Resumption Plan'). The Modification Plans and the Resumption Plan have been deposited in the Land Registry.

The Modifications are as follows:—

- (i) revision of the proposed limit of works area; and
- (ii) revision of the resumption/clearance limit in relation to modification as described in (i) above, including reduction of the scale of clearance for government land and proposed land resumption of Lot No. 523 (Portion) in D.D. 210 and increase of the scale of proposed land resumption of Lot No. 870 (Portion) in D.D. 217.
