## PWP ITEM NO. 6820TH UPGRADING OF REMAINING SECTIONS OF KAM TIN ROAD AND LAM KAM ROAD

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan Nos. WD6820TH-GZ0001 to WD6820TH-GZ0009 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:----

- (i) upgrading of a section of Kam Tin Road of approximately 1.9 kilometres long between Tung Wui Road and Fan Kam Road to a 10.3 metres wide single two-lane carriageway;
- (ii) upgrading of a section of Kam Tin Road of approximately 2.1 kilometres long between Fan Kam Road and Lam Kam Road and a section of Lam Kam Road of approximately 1.3 kilometres long between Kam Tin Road and Kadoorie Farm and Botanic Garden to a 7.3 metres wide single two-lane carriageway;
- (iii) construction of carriageways and footpaths;
- (iv) permanent closure and conversion of sections of the existing carriageways into footpaths, amenity areas and noise barrier;
- (v) permanent closure and conversion of sections of the existing footpaths into carriageways and noise barrier;
- (vi) permanent closure and conversion of sections of the existing amenity areas into carriageway and footpath;
- (vii) temporary closure and reconstruction of sections of the existing carriageways, footpaths and amenity area; and
- (viii) ancillary works including landscaping, drainage, slope improvement and street lighting works, implementation of environmental mitigation measures, installation of street furniture and traffic aids, noise barriers and retaining walls, and reprovisioning of affected structures/facilities, etc.
