TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths within the limit of works area as shown on Plans Nos. 60044963/GAZ/1015 to 60044963/GAZ/10121 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 5157 published on 21 August 2009 and 28 August 2009. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 22 June 2017 to 21 June 2018, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a dual 2-lane elevated carriageway between the Hong Kong—Zhuhai—Macao Bridge Hong Kong Boundary Crossing Facilities and North Lantau Highway ('the NLH') with associated slip roads, as well as modification and realignment of sections of the NLH and Cheung Tung Road at North Lantau, and associated works.
