The Plans and scheme were referred to in G.N. 5157 published on 21 August 2009 and 28 August 2009. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 21 July 2017 to 20 July 2018, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and cycle tracks to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a toll plaza and associated carriageways, as well as modification and realignment of sections of Lung Fu Road and Lung Mun Road at Tuen Mun, and associated works.
