Note 1 to Note 10 Applicable to Drawing Nos. H6144, H6145, H6148 and H6149:

- 1. All dimensions are in millimetres.
- 2. Colour of painting to BS 5252F (1976):
  - (a) Logo: Red, Code 04E53
  - (b) Letters, characters & lines : Black, Code 00E53
  - (c) Other: Yellow, Code 08E51
- 3. The face of the board shall be constructed in retroreflective materials conforming to "Class RA1" of BS EN 12899-1.
- 4. The board shall be made of 3mm thick aluminium backing plate conforming to BS EN485.
- 5. For details of Highways Department's logo, refer to drawing no. H6101.
- 6. For details of cartoon figure, refer to drawing no. H6143.
- 7. The information of the publicity board shall be printed in English and Chinese and shall be clear and legible. Free-hand writing is not permitted.
- 8. For works not carried out by Highways Department,
  - (a) the telephone no. shall be replaced by a telephone no. manned 24 hours by "the promoter of the works" \*to answer any enquiries or complaints; and
  - (b) the name and logo shall be replaced by the name and/or logo of "the promoter of the works" \*.
- 9. For Type 'A' Small Publicity Board and Type 'A' Publicity Board for Motorists, the 'Original Completion Date' and the 'Anticipated Completion Date' shall be approved by the Engineer of "the promoter of works" \*, which shall be the best estimated date of re-opening of the road for the interest of the public. It should take into account delays which will likely be materialized eventually, such as delay by inclement weather during the wet season. In this context, the dates may not necessarily be equal to the contractual completion date of the contract or the expiry date of the excavation permit concerning the road opening. At the outset of the respective roadwork, the 'Anticipated Completion Date' shall be the same as the 'Original Completion Date'. The 'Original Completion Date' shall be frozen throughout the period of road works to serve as a baseline for reference by the public. When deferral of re-opening of the road is anticipated, the 'Anticipated Completion Date' shall be revised as early as possible. The revised 'Anticipated Completion Date' should not be bounded by the contractual completion date or excavation permit expiry date.
- 10. For Type 'B' Small Publicity Board and Type 'B' Publicity Board for Motorists, the "Original Completion Date of This Section", the "Anticipated Completion Date of This Section" and the "Anticipated Completion Date of All Sections" shall all be approved by the Engineer of "the promoter of the works"\*. Similar to Note 9 above, if later on the "Anticipated Completion Date of This Section" and/or the "Anticipated Completion Date of All Sections" are anticipated to be deferred, they shall be revised in order to indicate the best estimated dates of re-opening the roads (which are not necessarily the contractual completion date or excavation permit expiry date).

- 12. The publicity board shall be displayed at a prominent location and orientated towards pedestrians for the public's reference.
- 13. For a work site (including decked areas) less than 50 metres in length, one publicity board shall be provided. For a work site (including decked areas) longer than 50 metres in length, publicity boards shall be provided at the ends of the site and along the site at a maximum spacing of 50 metres.
- 14. The publicity board shall be securely mounted on a stable structure (e.g. temporary barrier, hoarding or railing).
- 15. Using plastic backing plate instead of aluminium backing plate is permitted. The face of the plastic publicity board shall not show signs of deterioration, such as cracking, scaling, blistering, delamination and corrosion.

  - (i) the Permittee of an Excavation Permit or
  - (ii) the Permittee of an Expressway Permit.
