

## LAND (MISCELLANEOUS PROVISIONS) ORDINANCE (Chapter 28)

(Notice under section 18C(1)(b) for specification of classes of streets as newly constructed street and the duration for which such classes of streets shall not be used for any excavation)

Pursuant to section 18C(1)(b) as added to the Land (Miscellaneous Provisions) Ordinance (Chapter 28) by virtue of the provisions of the Land (Miscellaneous Provisions) (Amendment) Ordinance (Ord. No. 17 of 2003), notice is hereby given that the Director of Highways has specified the classes of streets of the description in Column 2 as classes of newly constructed streets and the duration for which and the extent to which such classes of streets shall not be used for any excavation in Column 3 and Column 4 of the following Schedule respectively.

## SCHEDULE

Classes of streets as newly constructed street and the duration for which and extent to which such classes of streets shall not be used for any excavation

<i>Class</i>	<i>Description</i>	<i>Duration</i>	<i>Extent</i>
(1)	Footpath constructed or reconstructed (other than those in Class 3 below) which has been taken over for maintenance by Highways Department for a period of less than a year.	1 year from the date of taking over by Highways Department for maintenance	Wholly or any part/s thereof
(2)	Carriageway resurfaced (other than those in Class 4 below) which has been taken over for maintenance by Highways Department for a period of less than a year.	1 year from the date of taking over by Highways Department for maintenance	Wholly or any part/s thereof
(3)	Footpath constructed or reconstructed within the area designated as full time or part-time pedestrian area which has been taken over for maintenance by Highways Department for a period of less than 2 years.	2 years from the date of taking over by Highways Department for maintenance	Wholly or any part/s thereof
(4)	Carriageway resurfaced with colour asphalt which has been taken over for maintenance by Highways Department for a period of less than 3 years.	3 years from the date of taking over by Highways Department for maintenance	Wholly or any part/s thereof
(5)	Carriageway constructed or reconstructed (including those carriageway constructed or reconstructed with paving blocks) which has been taken over for maintenance by Highways Department for a period of less than 5 years.	5 years from the date of taking over by Highways Department for maintenance	Wholly or any part/s thereof

A set of drawings which may be updated from time to time showing all streets which have been classified as any one of the above mentioned classes of streets, and which may be inspected by members of the public free of charge at the offices of Highways Department at 7th Floor, North Point Government Offices, 333 Java Road, Hong Kong; 13th Floor, Nan Fung Commercial Centre, 19 Lam Lok Street, Kowloon Bay, Kowloon; and 2nd Floor, Ho Man Tin Government Offices, 88 Chung Hau Street, Ho Man Tin, Kowloon during the following hours when those offices are normally open to the public:—
