THIS DRAWING IS PREPARED BASED ON DRAWING NO. WIL-G04 (REVISION 1) AND IS INTENDED TO SHOW SECTIONS OF QUEEN'S ROAD WEST AND WHITTY STREET (HIGHLIGHTED IN BLUE AND PURPLE RESPECTIVELY) OF WHICH PARTS OF THE CARRIAGEWAY AND FOOTPATH WIDTHS ARE TO BE TEMPORARILY CLOSED.
